NOTICE OF RACE

1.0 RULES

1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing (RRS)*.

1.2 The Sailing Instructions will change RRS 40 to require that a personal flotation device be worn while racing. Changes to the RRS will appear in full in the Sailing Instructions. The Sailing Instructions may also change other racing rules.

2.0 ELIGIBILITY AND ENTRY

2.1 This regatta is open to boats of the following classes: Bear, Bird, Folkboat, IOD, and Knarr.

2.2 Each class must have six boats registered by June 1, 2010 in order to participate.

2.3 Eligible boats may enter by completing the online entry form located at www.stfyc.com. Forms must be completed **prior** to June 1st to take advantage of the lower entry fee.

3.0 FEES

3.1 Entry fee is \$90 if received **prior** to June 1, 2011, and is \$180 if received thereafter up to 1400 hours on Friday June 3.

3.2 Entries will receive a \$5 discount with proof of current US SAILING membership.

4.0 SCHEDULE

4.1 Racing will be held on Friday June 1st, Saturday June 2nd and Sunday June 3rd.

4.2 One race is scheduled on Friday, June 1st. The first Warning Signal will be at 1800 hours.

4.3 Two races are scheduled on Saturday, June 2nd with the first Warning Signal at 1100 hours. A complimentary "Slider" buffet will be provided after the second race of the day.

4.5 Two races are scheduled on Sunday, June 3rd with the first Warning Signal scheduled for 1130 hours. All sailors and their guests are welcome to attend a complimentary trophy ceremony following racing on Sunday.

5.0 SAILING INSTRUCTIONS

Sailing instructions will be available at the StFYC Official Regatta Notice Board and on the StFYC website on or after Thursday June 1st. Changes to the sailing instructions will be posted on the StFYC Official Regatta Notice Board and may be posted on the StFYC website.

6.0 RACING AREA

The race area will be set on the San Francisco City Front utilizing inflatable marks.

7.0 SCORING

One completed race will constitute a series. Five races are scheduled. A boat's series score will be the total of all her race scores.

8.0 BERTHING

Yachts competing in the event may be moored free of charge at the StFYC guest docks one night prior to the beginning of racing and one night after racing concludes. Yacht owners are responsible for applicable docking fees before or past this allowance. Docking privileges are subject to availability and require approval of the Dockmaster (415.820.3727). StFYC assumes no liability for loss of, or damage to, boats, gear or equipment brought onto Club premises.

9.0 DISCLAIMER OF LIABILITY

Competitors shall participate in the regatta entirely at their own risk (see RRS 4, DECISION TO RACE). The Organizing Authority does not accept any liability for material damage or personal injury or death sustained in conjunction with, prior to, during, or after the regatta.
